### JOINT CIRCULAR No. 20

Dear Sir/Madam

#### Car Allowances

I write to inform you of the new rates payable under section 4, paragraph 3 of the Police Support Staff Handbook for the above allowance. It is recommended that Police Support Staff required to use their car on business shall, after authorisation, be paid allowances in accordance with the arrangements set out below. These new rates are effective from 1 April 2002.

#### Essential Users

An essential user is a member of staff for whom it is deemed essential that they have a motor car at their disposal whenever required. The recommended allowance for essential users are as follows:

### **Casual Users**

A casual user is a member of staff for whom it is merely desirable that a car should be available when required. The recommended mileage rates for casual users are as follows:

Mileage rate up to 8,500 miles	35.8p	39.9p	49.4p
Mileage rate over 8,500 miles	10.1p	11.1p	12.4p
Petrol Element	6.631p	7.073p	7.763p
Amount of VAT per mile in petrol element	0.988p	1.053p	1.156p

The above allowances are based on a price of 70.02p per litre (318.3p per gallon) for unleaded petrol.
